STAFF REPORT – June 1, 2023

To: Chair and Members of the Recreational Users Committee

RE: Volunteer Program Update

Stage One of the Trail Maintenance Volunteer Program has commenced. Volunteers are pruning and removing certain trail blockages on predetermined single-track trails for clearance within the West Forest. This work is complementing Staff maintenance efforts. The intent of Stage One is to provide a single-track trail network with a minimum clearance standard to facilitate safe passage.

Ganaraska Region Conservation Authority (GRCA) is currently developing Stage Two of the Volunteer Program. Stage Two will focus on the of clearing pre-existing single track in the Central Forest. This effort is setting groundwork to develop a series of looping trails that will connect Ganaraska Forest Centre and Horse Trailer Parking Lot to single track loops. Staff will be hosting Stage Two training and orienteering in the coming weeks.

STAFF REPORT - June 1, 2023

To: Chair and Members of the Recreational Users Committee

RE: Central Forest Trail System

Historically, Central Forest single track, dual track and Forest roads have overlapped. This causes challenges during winter operations, specifically with regards to cross country ski trails. To facilitate specific trail needs, Ganaraska Region Conservation Authority (GRCA) has been working towards developing a process to separate trail types. Additionally, Staff are assessing the safety and functionality of the trail system.

A new snowshoe trailhead and A-Loop bypass is currently being developed. This will allow people to bypass Tree Top Trekking games area, a dangerous hill at the trailhead and separate the ski trail from snowshoe trail. Staff have marked the trail and removed blockages. An excavating contractor will be clearing and creating the trail surface. Staff expect this work to be completed by mid-summer. The snowshoe trails can be used year-round.

Additionally, Staff are working towards redeveloping the single-track network in the Central Forest. Currently single track is sporadic and infringes on the cross country ski trail in several locations. This causes challenges for maintenance and to trail users. As the plan develops the several sections of single-track will relocated away from the ski trails and some older sections of single-track will be realigned to create a series of continuous loops that will connect with the Ganaraska Forest Centre. Staff expect this project to be a multi-year project that will require significant investment, partnership, and community involvement.
