STAFF REPORT – November 23, 2023

TO: Chair and Members of the Ganaraska Region Source Protection Authority

RE: Public Consultation for Proposed Amendments to the Ganaraska Source
Protection Plan and Assessment Report

Ganaraska Region Conservation Authority (GRCA) staff have carried out the 2023 Public Consultation Phase regarding the Section 36 updates for the Ganaraska Source Protection Plan and Assessment Report required through the amendments under Section 36 of the Clean Water Act (CWA), 2006. Section 36 of the CWA requires a minimum 35-day Public Consultation Period to provide the opportunity to review and comment on the proposed amendments for those responsible for implementing policies in the Ganaraska Source Protection Plan.

From September 1st to October 5th, documents that were circulated included the Notice of Public Consultation, Summary of Proposed Amendments to the Ganaraska Source Protection Plan and Assessment Report, and links to the track changes versions of relevant documents. Digital and hardcopy versions of the reports were made available in the main office and online for review and comment during the public consultation period.

The updated Plan will be submitted to the Ministry of Environment, Conservation and Parks (MECP) in early December by the Trent Conservation Coalition Source Protection Committee.
