#### **STAFF REPORT – September 1, 2022**

#### TO: Chair and Members of the Recreational Users Committee

#### **RE: Forestry and Trail Update Pertaining to the Derecho Storm**

The Derecho storm that struck the Ganaraska Forest on the afternoon of May 21, 2022 caused significant damage to the Ganaraska Forest and trail systems. The Ganaraska Region Conservation Authority (GRCA) Forester, Gus Saurer, estimates that scattered blocks of trees totalling approximately 600 acres have suffered significant damages, including blowdown. This amount of damage is a major threat to the forest ecosystem and impacts ways in which the Forest is managed. To address these threats the GRCA has contracted two logging companies to implement salvage-logging efforts. This logging activity is in addition to annual harvest operations.

Three logging crews are currently accessing the Ganaraska Forest from many locations surrounding the Central and West Forests. In an effort to gain access to areas of the Forest with significant storm damage, logging crews are clearing downed trees, removing standing hazards and widening narrow trails to accommodate for the safe access of logging crews. GRCA estimates salvage logging efforts to continue well into the fall, at which point regular annual logging will continue as planned. GRCA estimates standard logging efforts to continue into the winter of 2023.

In addition to large-scale blowdowns, GRCA staff have encountered hundreds of downed or hazardous trees blocking trails throughout the Ganaraska Forest. GRCA staff and contract logging crews are encountering unusual tree damage caused by the Derecho storm. Staff are working diligently to remove hazards to facilitate the opening of the trail network where possible. Due to a precautionary approach, the GRCA is not authorizing public volunteer opportunities to assist with clean up efforts until all hazards have been isolated or removed. Considering the overwhelming cleanup effort requirements, the GRCA staff is very thankful for the assistance received from Rideau Valley Conservation, Saugeen Valley Conservation and Northumberland County Forest who provided professional forestry crews to assist with trail clearing efforts. To date, most of the primary roads and ski trails have been cleared, although many downed trees and standing hazards remain elsewhere around the Forest. Fortunately, most of the East Forest has experienced less storm damage than the West and Central.

Due to the success of the clearing and logging efforts, the GRCA is planning a limited reopening of the Ganaraska Forest on September 30, 2022. This reopening provides Ganaraska Forest members and day pass holders with limited access to the trails which have been cleared of known hazards. Staff and contractors continue to clear hazards and the GRCA will open more tails as hazards are addressed. In addition, to providing a safe trail system for the public, GRCA Provincial Offences Officers and Police will be strictly enforcing all trail closures that remain after the September 30, 2022 reopening date.

#### **STAFF REPORT – September 1, 2022**

#### To: Chair and Members of the Recreational Users Committee

#### **RE: Ganaraska Forest Operational Recovery Plan of Recreational Trails**

The Ganaraska Region Conservation Authority (GRCA) is viewing the disastrous Derecho Storm as an opportunity to improve recreational trail systems in the Ganaraska Forest while enhancing, restoring and protecting the ecological integrity of the Ganaraska Forest. In order to do so, the GRCA has developed an Operational Recovery Plan of Recreational Trails (ORP), that is adaptive to the ongoing challenges that storm recovery is posing. The implementation actions contained in the ORP considers the Ganaraska Forest ecosystem as the primary focus, with education and recreation programs as the secondary focal points.

Implementation of the ORP will result in the permanent closure of certain Forest areas, access points and trails to recreational users, but also the development of new trails/trail modifications where appropriate. Decision making will be based on ecological factors, as well as health and safety of recreational users and future trail maintenance and access considerations. The GRCA will preserve multi-use recreational opportunities.

#### **RECOMMENDATION:**
